I represent and warrant that I or those I am a guardian or parent for are sufficiently healthy and physically able to engage in physical activities associated.

WAIVER OF LAWSUIT/LIABILITY: I hereby forever release and waive my right to bring suit against SDAS and its past and present owners, officers, directors, managers, officials, trustees, agents, employees, or other representatives in relation to my visitation of the SDAS properties or related to my child or ward's visitation. I further hereby forever release and waive my right to bring suit against any and all SDAS vendors that are providing services or goods to SDAS (collectively all parties released in this paragraph, the "Releasees") in relation to my visitation of the SDAS properties or related to my child or ward's visitation. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I or my child or ward may have to seek damages, whether known or unknown, foreseen or unforeseen. It is my express intent that this Waiver of Liability binds my family members, spouse, heirs, assigns, personal representatives and anyone else entitled to act on my behalf to the extent they act on my behalf, and is deemed as a release, waiver, discharge and covenant not to sue the Releasees.
